

PRIVACY POLICY

We at BulkREOnetwork.com recognize your need and desire to preserve the privacy of your nonpublic information. Safeguarding your nonpublic information is also very important to us, and we have adopted company-wide standards and procedures to protect your information. The following Privacy Policy affirms our commitment and continued efforts to safeguard your private information.

Information You Provide

When you register for the service with BulkREOnetwork.com, you are asked to provide certain nonpublic personal information, such as your name, address, telephone number, e-mail address, real estate license (if applicable), and company name.
